Monroe City (Owner) is requesting Bids for the construction of the following Project: Monroe City – Secondary Irrigation Meters.

Bids for the construction of the Project will be received at the Monroe City Offices located at 10 N Main St, Monroe, UT 84754, until Tuesday, May 14, 2024 at 10:00 A.M. local time. At that time, the Bids received will be publicly opened and read.

The Project includes the following Work: Installation of 865 ultrasonic radio-read irrigation meters on existing secondary irrigation system, and associated work. Bids will be received for single contract.

Owner anticipates that the Project's total bid price will be approximately \$1,760,000. The Project is expected to begin October 15, 2024, and is expected to be substantially completed by April 1, 2025.
