**MONROE CITY COUNCIL:** The Monroe City Council holds its regular council meetings on the second and fourth Tuesday of each month. Meetings begin at 7:00 p.m. at the Monroe City Hall, 10 North Main Street, Monroe, Utah.

**MUNICIPAL BUILDING AUTHORITY OF MONROE CITY:** The regular meetings of the Municipal Building Authority of Monroe City are held on the second and fourth Tuesday of each month as deemed necessary by the Board of Trustees. Meetings begin at approximately 7:00 p.m. at the Monroe City Hall, 10 North Main Street, Monroe, Utah.

**MONROE CITY PLANNING COMMISSION:** The Monroe City Planning Commission holds its regular commission meetings on the third Tuesday of each month. Meetings begin at 7:00 p.m. at Monroe City Hall, 10 North Main Street, Monroe, Utah.
